

Consent Form

I, the undersigned, hereby freely give my consent to [name of Bunge legal entity] (“Bunge”) as data controller for the processing of my personal data concerning health for the following purposes:

- Verifying my eligibility to work on Bunge’s premises;
- Investigating the causes of any accidents that may occur on Bunge’s premises in the course of or in connection with the work I perform or have performed for Bunge; and

I agree to provide Bunge with a health certificate for the purposes described above and which contains the following information: [to be adapted case by case]

- Name; Place and date of birth; Home address; Nationality;
- The respective medical checks performed by the doctor in order to verify my adequate health condition for the specific work I need to perform;
- The medical decision on my eligibility to the specific work, including the medical reasons of a potential refusal or restriction.

I understand that Bunge has a legitimate interest in ensuring a safe working environment on its premises. I have been informed that, to this end, Bunge requires workers performing works on its premises to provide proof of an adequate health condition insofar as it is relevant for the performance of such works concerned and I have had the opportunity to ask questions regarding the use of my data by Bunge. I understand that Bunge may exclude me from any work on its premises for which an adequate health condition is required in order to ensure a safe working environment in the event that I fail or refuse to provide proof of an adequate health condition.

I understand that my personal data may be shared with other companies within the Bunge Group or third parties which may be located outside of my country of origin, exclusively for the purposes described above. I have been informed that Bunge has implemented appropriate data protection safeguards for international data transfers.

I understand that my personal data provided below will remain confidential and may be used in the event Bunge needs to prove that it has obtained valid explicit consent for the data processing.

I may withdraw my consent at any time, by written notice to Bunge at the postal or the email address provided below. The withdrawal of my consent will take effect as of the date of receipt by Bunge of such written notice, concerning future use of the data which is subject to my consent. I understand that Bunge may exclude me from any future work on its premises in the event that I withdraw my consent as Bunge would not be able to ensure anymore safe working environment on its premises.

I have been provided with a copy of Bunge’s EU Customer and Business Partner Data Protection Notice informing me, among other things, about my rights under applicable data protection law, applicable retention periods and Bunge’s data protection practices which can also be found at <https://www.bunge.com/eu-customer-and-business-partner-data-protection-notice>.
